Emissions reduction targets

In order to continue our progress to achieving net zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next three years to 13.9 tCO2e by 2028. This is a reduction of 75%. We project that carbon emissions will decrease over the next five years to 0 (zero) tCO2e by 2030. This is a reduction of 100%.

Carbon reduction projects

Completed carbon reduction initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equate to 0 tCO2e, due to the business growth and expansion within this period, but reductions will be evident in the 2025 reporting figures, due to changes made in the current year. These measures will be in effect when performing the contract.

- a) Fleet Electrification
- Transitioning 40% of fleet to electric by end of 2025
- Evaluating routes and depot infrastructure to maximise EV use
- Implementing route optimisation software to cut emissions
- b) Employee EV Incentives
- Offering salary sacrifice schemes for staff to obtain electric vehicles
- Internal campaigns to promote low-carbon commuting
- c) Renewable Energy Supply
- All electricity is now sourced from a 100% renewable provider
- Installation of motion sensors and energy-efficient LED lighting across our facilities
- d) Paper Shredding & Reforestation
- Launching initiative to plant one tree for every 100kg of shredding destroyed
- Partnering with certified reforestation charities or carbon credit providers
- e) Digitalisation and Scan-on-Demand
- Promoting digital transformation services to reduce physical storage and transportation
- Educating clients on environmental benefits of scan-on-demand

Future carbon reduction initiatives

In the future we hope to implement further measures such as:

- Increase EV fleet share to 80% by 2027
- Conduct Scope 3 emissions mapping to identify additional reduction areas
- Upgrade warehousing to net-zero energy buildings (solar panels, battery storage)
- Introduce carbon literacy training for all staff
- Expand tree-planting program to include client-sponsored options
- Implement a Green Client Charter encouraging digital-first record management

Monitoring and Reporting

- Annual carbon footprint reporting with Planet Mark verification
- Quarterly internal reviews to track progress on emissions reductions

- Emissions and progress data made publicly available on company website and ESG reports

Stakeholder Engagement

- Regular sustainability updates to clients and partners via monthly newsletters
- Collaboration with local councils and green networks
- Encouraging suppliers to share and improve their own sustainability data

Risks and Mitigation

Risk: EV charging infrastructure delays

Mitigation: Partner with multiple installers and apply for grants

Risk: Client resistance to digitisation

Mitigation: Incentivise digital services and provide training/support

Risk: Rising electricity prices

Mitigation: Long-term contracts with renewable suppliers and self-sufficiency through solar
